By signing this form if you give your consent to the following:

- If a player or parent/guardian is feeling unwell or has suspected COVID-19 symptoms, then they must not attend training or matches. They must follow government guidance regarding isolating. Contact must be made with the age group manager.
- If a player or parent/guardian is confirmed as having COVID-19 symptoms, then they must contact the age group manager
- Locations, start times and finish times will be set by the age group manager
- Attendance at all training sessions and matches will be recorded by the age group manager or coach.
- Social distancing must always be adhered to
- All parent/guardians and players must always follow the managers and coaches' instructions
- Coaches or parent/guardians must not give lifts to other coaches, parents/guardians, or players
- Players must arrive at training in clean kit for training and match days. Changing and shower facilities must not be used.
- Players must have their own kit bag, drink, and hand sanitiser. All players will be given a designated cone or area for their equipment. Any players items must be put in their designated area
- Bibs and equipment must not be shared
- Goal celebrations must be avoided
- Players must not spit or chew gum
- Do not shout or raise voices (to limit the spreading the disease)
- If there are any incidents where the rules are consistently being broken during training or a match, then the parent / guardian and/or player will be asked to leave the venue. If behaviour continues then training / matches will stop
- A face mask should be worn by the parent/guardian while they wait to collect their player

As a Charter Standard Club, Galmington Dragons FC acts in accordance with the Code of Practice & Rules set by the English Football Association (EFA) & Somerset County FA (SFA). The club requires all Managers, Coaches, and any Volunteers to adhere to any requirements / guidance set by EFA/SFA. Galmington Dragons have the required risk assessment in place for COVID-19
